Re: Review of the Loan Documents for the Oglala Sioux Tribe

Dear President Killer:

This letter responds to your October 22, 2021 request on behalf of the Oglala Sioux Tribe for the Office of the General Counsel, National Indian Gaming Commission, to review certain loan documents. The request asks for my opinion as to whether the submitted loan documents are management contracts requiring the NIGC Chairman's approval pursuant to the Indian Gaming Regulatory Act. The request also asks for my opinion as to whether the loan documents violate IGRA's requirement that a tribe have the sole proprietary interest in its gaming operation.

In my review, I considered the following submissions (collectively, "the Loan Documents"):

- Loan Agreement, marked "4824-0988-8506.7";
- Promissory Note, marked "4824-0400-4858.3";
- Security Agreement, marked "4828-2754-7386.5";
- Bank Account Pledge Agreement, marked "4834-3340-1854.3"; and
- Assignment Agreement, marked "4814-3634-9434.4".

The Loan Documents contain terms similar to other agreements that OGC has previously reviewed and analyzed. Some of these opinion letters may be found on the NIGC's website. Applying the same analysis here, it is my opinion that, collectively, the Loan Documents are not management contracts and do not require the approval of the NIGC Chairman. It is also my opinion that they do not violate IGRA's sole proprietary interest requirement.

It is my understanding that the Loan Documents are represented to be in substantially final form, and any further changes will not be material to OGC's analysis. This opinion shall not apply if the Loan Documents change in any material way prior to closing or are inconsistent with assumptions made herein. Further, this opinion is limited to the Loan Documents listed above and does not include or extend to any other agreements.

Argus Leader Media*. Any claim of confidentiality should also be supported with "a statement or certification by an officer or authorized representative of the submitter." Please submit any written objection to FOIASubmitterReply@nigc.gov within thirty (30) days of the date of this letter. After this time elapses, the letter will be made public and objections will no longer be considered.
