



## Press Conference: 30 years in the making – NIGC to announce 2016 gross gaming revenues

WASHINGTON, July 11, 2017 –National Indian Gaming Commission invites the public, media and Tribes to attend a press conference on July 17<sup>th</sup> at 1:00 p.m. EST. The Commission will announce 2016 gross gaming revenues for the Indian gaming industry. Indian gaming continues to be a catalyst for economic development, self-determination, and self-sufficiency in Indian country and is conducted in accordance with the Indian Gaming Regulatory Act for 499 Indian gaming establishments operated by 245 federally recognized gaming tribes across 29 States.
