### CHAIRMAN E. SEQUOYAH SIMERMEYER



E. Sequoyah Simermeyer (Coharie) is the Chairman of the National Indian Gaming Commission. The United States Senate unanimously confirmed his nomination in November 2019 after which he was appointed by President Donald J. Trump to a three-year term. As Chairman, he is responsible for the federal regulatory agency's daily operations including its eight regional offices as well as its national and local training and technical assistance efforts. He has the authority to issue civil enforcement fines and temporary closure orders for regulatory violations by gaming operations on Indian lands. As a member of the National Indian Gaming Commission's three-member commission, he is responsible for regulating and ensuring the integrity of the more than 520 Indian gaming facilities, associated with nearly 247 tribes across 29 states.

Before serving as Chairman, Simermeyer was appointed by the Secretary of the Interior in November 2015 to serve as the National Indian Gaming Commission's Associate Commissioner. As an Associate Commissioner he heard appeals before the full Commission, promulgated Agency regulations, and voted on matters related to the Agency's budget. Additionally, he directed the Agency's Office of Self-Regulation during which time the Commission issued certificates of self-

regulation to two of the current six self-regulated tribes.

Prior to joining the NIGC, Simermeyer advised the Chairman to the United States Senate Committee on Indian Affairs. In that capacity he helped draft legislative proposals and committee reports, prepared oversight and legislative hearings, and advanced the Committee's work on priority issues facing Indian country. Simermeyer also served as Deputy Chief of Staff and as counselor to the Department of the Interior's Assistant Secretary for Indian Affairs.

Simermeyer's professional and academic experience has focused on government-to-government relationships that impact federal Indian policy and which empower tribal communities to provide for their people. Simermeyer was named to the National Center for American Indian Enterprise Development's 40 Under 40 list in 2011 and was a 2014 nominee for the Native American Bar Association–D.C. Chapter Award for "Excellence in Government Service."

Simermeyer graduated with a Bachelor of Arts degree from Dartmouth College, N.H., a Masters of Study in Environmental Law from Vermont Law School, Vt., and received his Juris Doctor from Cornell Law School, N.Y.

### VICE CHAIR KATHRYN ISOM-CLAUSE



Kathryn Isom-Clause (Taos Pueblo) is the Vice Chair of the National Indian Gaming Commission. As such, she is one of three commissioners responsible for regulating and ensuring the integrity of the more than 520 Indian gaming facilities, associated with nearly 247 tribes across 29 states. Isom-Clause was appointed by the Secretary of Interior on March 14, 2016 for a three-year term.

Prior to joining the NIGC, Isom-Clause served as a senior counselor to the Assistant Secretary – Indian Affairs at the U.S. Department of the Interior. In this position, she advised the Assistant Secretary on Indian gaming matters, including tribal-state gaming compacts, environmental compliance issues and revenue allocation plans. She also chaired interagency working groups on sacred sites and homelessness, and coordinated listening sessions and roundtables with tribal stakeholders. In addition, her portfolio included the restoration and protection of tribal homelands. Prior to joining the federal government, Isom-Clause provided legal advice and representation to tribal clients on a wide range of federal Indian law and policy issues important to Indian Country.

Isom-Clause graduated with a Bachelor of Arts degree from Wellesley College, Mass. and received her Juris Doctor from Columbia University School of Law, N.Y.

### DIRECTOR OF COMPLIANCE (Acting) TOM CUNNINGHAM



Tom Cunningham (Seminole Nation) is the acting Director of Compliance at the National Indian Gaming Commission, an independent federal regulatory agency established within the Department of the Interior. In this position, Cunningham monitors compliance of tribal gaming operations on Indian lands in accordance with the Indian Gaming Regulatory Act and NIGC regulations for the Division of Compliance, which encompasses eight Regional Offices and the Audit and Training Programs. In addition, Cunningham will provide support in implementing the Commission's priorities.

Prior to becoming Director in June of 2020, Cunningham served as the Assistant Director of Compliance since April of 2017 and prior to that he served as the Region Director of NIGC's Oklahoma City office in 2009 and a Field Investigator for the NIGC's Tulsa, Okla. Office beginning in 2007. In these roles, Cunningham ensured tribal compliance with the Indian Gaming Regulatory Act, by providing training and technical assistance. Before joining the NIGC, Cunningham spent thirteen years in law enforcement including assignment to the Drug Enforcement Administration, and working joint investigations with the

Federal Bureau of Investigations and the US Attorney's Office. Cunningham also served as Seminole Nation of Oklahoma Gaming Commission Chairman in 2003.

Cunningham is the recipient of the Director's Award for Distinguished Service from the White House's Office of the National Drug Control Policy in 2006 and the NIGC Chairman's Award in 2017.

Cunningham received a Bachelor of Science degree from East Central University, Ada, Okla. in 2003 and is pursuing a Master's of Jurisprudence from the University of Tulsa, Okla.

Fixico received the highest award given by NIGC, winning the NIGC Chairman's award in 2018 with the Training Department.


Fixico completed her Master's in Public Administration degree from Northern Arizona University and a Bachelor's of Science degree in criminal justice from Arizona State University.
