AUDIT COURSE DESCRIPTIONS:

Audit Follow Up - Enhancing Compliance *Virtual Live Stream option

This course focuses on enhancing compliance through effective follow-up of internal audits, with a specific focus on NIGC MICS requirements. Participants will learn how to plan and execute follow-up reviews, determine the timing for follow-up, request relevant documents, and perform necessary testing. The course will cover handling unresolved findings and proper documentation for follow-up testing. Activities include reviewing audit findings, scheduling follow-up tests, and ensuring compliance has been achieved.

Auditing Revenue — Top Challenges *Virtual Live Stream option

Auditing revenue continues to account for a significant percentage of findings in Agreed-Upon Procedures (AUP) reports nationwide. This course will cover the NIGC revenue auditing requirements for common systems used in Tribal gaming operations and examine the challenges of auditing these systems. Attendees will gain an understanding of the intent behind the requirements and explore strategies for auditing player tracking, key security, and currency counter interface systems effectively.

Cyber Safety for Non-IT Professionals

ENVIRONMENTAL PUBLIC HEALTH & SAFETY (EPHS) COURSE DESCRIPTIONS:

Emergency Preparedness and the Opioid Epidemic: Fentanyl Awareness and Narcan Resources (Narcan Training Certificate)

This course will guide Tribal governments, regulatory commissions, casino team members and management in responding to critical and emergency situations and how to plan and respond to different kinds of natural and man-made disasters specific to their area, including a presentation by Indian Health Service about the opioid epidemic on fentanyl awareness and Narcan resources that includes hands on Narcan training and a completion certificate.

Creating, Implementing, and Activating your Emergency Preparedness and Response Plan.

Join us for a dynamic session where you will learn how a TGRA and Casino Operation work together to create an emergency preparedness and response plan, strategies for implementing that plan and a real-life scenario that occurred recently, will be shared where the emergency preparedness and response plan was activated across the casino and hotel for a positive outcome. You will also hear from a Compliance Officer from the Rapid City region and how she works with Tribes on Emergency Preparedness as well as her experience having worked in security for casinos. Lessons learned will be discussed as well as best practices when conducting drills involving not only the casino operations team but Tribal Police, Fire Department, local law enforcement and other first responders. You will participate in an in-class exercise to improve or create your own Emergency Preparedness and Response Plan.

Surviving an Active Threat: Run, Hide, Fight (Active Threat Training Certificate)

This 8-hour certificate course addresses the Run. Hide. Fight. response paradigm and guides non-traditional first responders in the various ways these methods can be employed. Because active threat incidents can occur anywhere, participants are encouraged to apply principles from this course to plans and procedures in their workplaces. The course covers the basic principles of the response paradigm as it pertains to response in the event of an active threat incident. Attendees will participate in table groups with a customized plan promulgation activity worksheet with shared findings through instructor led discussion. *Note: During the afternoon portion of the Run, Hide Fight session, attendees will only conduct a brief simulated walkthrough with no simulated gunfire, running, hiding, or fighting. Barricading tools, methods and best practices will be shown and discussed.

Training Certificate: To receive a training certificate, participants must complete a separate registration through a link from NIGC, provided by LSU prior to the training session. This includes obtaining a FEMA Student Identification (SID) Number, taking a brief multiple-choice pre-test. At the end of the training session, participants will complete a post-test and a course evaluation. Certificates will be sent via email upon completion.
