Dear Principal Chief Ellis:

This letter is in response to your request that the National Indian Gaming Commission ("NIGC") review and approve a recent amendment to the Muscogee (Creek) Nation's gaming ordinance. The amendment, NCA 05-051, was adopted on March 19, 2005, and approved on March 28, 2005, by the National Council of the Muscogee (Creek) Nation. The amendment was received by the NIGC on April 20, 2005.

The Chairman of the NIGC approved the Nation's original gaming ordinance on November 3, 1994, and an amended ordinance on February 22, 2002. This letter constitutes approval of the submitted amendment, NCA 05-051, under the Indian Gaming Regulatory Act, 25 U.S.C. § 2701 *et seq*.

Thank you for submitting the amendment for our review and approval. The NIGC staff and I look forward to continuing to work with you and the Muscogee (Creek) Nation in implementing the IGRA. # A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 21, § 4-102, ALLOWING FOR MILEAGE AND STIPENDS FOR GAMING OPERATIONS AUTHORITY BOARD MEMBERS TO ATTEND NATIONAL COUNCIL MEETINGS AND MILEAGE FOR OFFICIAL BUSINESS

Be It Enacted by the National Council of the Muscogee (Creek) Nation:

**SECTION ONE.** <u>AMENDMENT.</u> MCNCA Title 21, §4-102 is hereby amended to read as follows:

F. <u>Stipends/Mileage</u>. Gaming Operations Authority Board Members, except the ex-officio National Council member, shall receive a stipend of \$125.00 for attendance at each duly called meeting of the Board or duly called meeting of the National Council, provided that to receive a stipend for attendance at a National Council meeting the Board's attendance must be requested either by the Speaker, Chairperson of the Business & Governmental Committee or the Principal Chief. In addition to a stipend, Board members shall receive mileage for attendance at meetings, conferences, and site visits to gaming facilities under the GOAB's jurisdiction, provided attendance is in furtherance of a valid function of the Board. All mileage reimbursement shall be at the Nation's current rate in accordance with the Nation's travel policies and procedures.

**SECTION TWO.** <u>EFFECTIVE DATE</u>. The effective date of this amendment shall be the date of approval by the National Indian Gaming Commission; on the date the National Indian Gaming Commission determines that approval of the amendment is not necessary; or in the absence of issuance of approval or disapproval by the National Indian Gaming Commission, ninety (90) days from the date of submission of this amendment to the National Indian Gaming Commission, whichever date occurs first.

**ENACTED** by the Muscogee (Creek) National Council on this <u>19<sup>th</sup></u> day of <u>March 2005</u>.
