NIGC Announces Additional Tribal Consultations for February 2012

Washington, DC January 19, 2012 — The National Indian Gaming Commission (NIGC/Commission) announced today that it has scheduled an additional two consultations in February 2012 as part of its continued Regulatory Review process.

In April 2011, the Commission embarked on a regulatory review process that included Tribal consultations throughout Indian Country. As a result, NIGC has published several proposed rules in the Federal Register including, most recently, <u>25CFR Part 537</u>, <u>25 CFR Parts 556 & 558</u>, <u>25 CFR Part 502</u> and <u>25 CFR Part 573</u>, which were informed by deliberative conversations with Tribes and comments received by the public. The upcoming consultation sessions are a further opportunity for Tribes to provide the Commission with substantive input during the next phases of the regulatory review process.

The Commission invites all Tribal leaders and their designees to share their views with the Commission during the following scheduled consultations:
