Dear Tribal Leader:

This letter is to inform you about enhancements in the annual budget development process for the National Indian Gaming Commission (NIGC).

The NIGC's commitment to emphasizing accountability in its operations and innovation in its outreach extends to the NIGC budget development process. As the NIGC's Commissioners consider the coming year's budget, this letter requests your input on any views related to the impact from the NIGC budget on your community. In addition, this letter provides information about relevant budget material and announces an NIGC budget briefing for tribal leaders that will take place in September 2020.

Request for Tribal Input

As the Commission develops and finalizes its budget, your input and perspective as a tribal representative are invaluable. Your views will help the Commission to maintain the Agency's emphasis areas and to improve the efficiency and impact of the NIGC annual budget. As a fee-based federal agency, it is important for the NIGC to standardize an opportunity for your input. The process should involve direct outreach to tribes and build trust in the federal relationship with tribal governments.

Tribal leaders have a unique perspective on how the NIGC budget can protect the industry's reputation for integrity and promote long-term resilience as the industry looks to the future. Your views will enhance the Commission's coming Fiscal Year (FY) 2021 budget and any future Commission decision making during FY 2021.
