National Indian Gaming Commission Updates

NIGC Welcomes Commissioner Jeannie Hovland

Following her appointment by the Secretary of the Interior, Commissioner Jeannie Hovland began at the National Indian Gaming Commission on January 17, 2021. Commissioner Hovland joins the Agency with policy, management, and legislative expertise at the federal level. She is an enrolled member of the Flandreau Santee Sioux Tribe and is Oglala Lakota. She most recently served in leadership positions at the Department of Health and Human Services (HHS). Her experience includes advisory positions on federal Indian policy at the HHS, the Department of the Interior, and the United States Senate. NIGC Continues to Grow Outreach Opportunities to Promote COVID Response Resources

Considerations around event gatherings remains an important consideration for gaming regulatory bodies. In mid-December 2020, the Commission provided a briefing for Tribal leaders on resources available to assist tribe's in meeting their responsibilities for gaming operations' public health and safety. This included an overview of key resources and tools available at https://www.nigc.gov/commission.

The NIGC is committed to providing Tribal gaming facilities the most recent COVID-19 updates and resources available. The NIGC recently added additional information to highlight important NIGC resources around the topic of event gatherings for Indian Gaming operations. This information includes updated guidance from the Centers for Disease Control around event gatherings and considerations for the requirements maintained by Tribal gaming regulatory bodies. The updated event gathering resources can also be found on the NIGC COVID-19 Resources page. In addition, the NIGC Region Office Directors within the Agency's Compliance Division may provide assistance, and you or your staff may request a recorded copy of the December 2020 Commission Briefing for Tribal leaders on the NIGC's COVID Resources.

A commitment to communication has been an important part of the NIGC response to the COVID-19 pandemic along with collaboration and monitoring. Communication efforts have included an NIGC Informational Sessions Series, the regularly updated NIGC website's COVID Resources, and direct communications to tribal leaders and stakeholders.¹ The Commission

A dedicated NIGC email account provides a rapid response to any inquiries from Tribal officials or Indian gaming operators. Ongoing coordination with the NIGC's eight Region Offices provides local level coordination with the regulatory community and supports tribally-led decision making efforts.

continually identifies new means to maintain its commitment to communication around the important subjects related to the Indian gaming industry's response to the COVID pandemic.

The NIGC wants to support your tribe's efforts to inform the public and operations staff about the mitigation measures associated with ensuring the protection of public health and safety amid the pandemic. To complement your tribe's efforts in this area, the CDC has made available a variety of print and communication resources that can be found at https://www.cdc.gov/coronavirus/2019-ncov/communication. Signage can be used to promote awareness around event gathering considerations, emergency closure and reopening procedures, masking and social distance protocols. Additional guidance for signage and how to communicate safety protocols to employees and customers can be found in the NIGC's Model COVID-19 Infectious Disease Preparedness and Response Plan which can also be found on the NIGC's website. Additional Opportunity for Input on NIGC Fingerprint Program MOU

The Commission is providing Tribal leaders with an update on its efforts to improve the NIGC Memorandum of Understanding (MOU) with Tribes for participation in the NIGC fingerprint program. The update will be shared in a Dear Tribal Leader Letter sent during the week of February 15, 2021. The update will explain how the NIGC incorporated tribal feedback on an earlier draft MOU during the end of 2020. Much of the feedback improved the document's clarity. The update will also include information about a new opportunity to provide a final round of feedback before the MOU is finalized in the spring 2021. The MOU's improvements are driven by the Federal Bureau of Investigation's requirements particularly in the area of information security for all users of the National Crime Information Center database.

Tribal Leader Briefing on Agency's Quarterly Operations is Set for Mid-March

A telephonic briefing for tribal leaders will be held the week of March 15, 2021. The briefing will focus on the NIGC's last quarter of operations and is part of the NIGC's commitment to promote accountability in NIGC operations by encouraging greater tribal involvement in the Agency's planning processes. Updates on the NIGC operations have been an especially timely topic given the uncertainty in operational needs and resources that exist because of the COVID pandemic's impact on the Indian gaming industry. Through modifications to promote operational efficiency and public health and safety measures, the NIGC continues to take proactive planning steps related to its operations. These planning steps ensure that all NIGC operations continue without interruption and establish roles for tribal involvement in shaping the NIGC budget development process. Additional information to register for the briefing will be sent to Tribal leaders in a Dear Tribal Leader Letter in the coming days.

NIGC Welcomes Executive Memorandum on the Importance of Tribal Consultation and Strengthening Nation-to-Nation Relationships

President Biden's January 26, 2021, Executive Memorandum underscores the value of strong intergovernmental relationship including meaningful consultation with Tribes. As an independent Agency, the NIGC is committed to supporting and respecting the Nation-Nation relationships and the benefit of consultation to improving the industry's integrity. The NIGC is beginning an internal review of its consultation practices and efforts to strengthen our Nation-to-Nation relationship with tribal governments. This review will look to identify opportunities to improve the NIGC's agency practices as a way to support strong tribal governments. Outreach to tribal governments for their involvement will be part of this review process. This outreach will strive to account for the demands on tribal governments' time and resources. The Commission welcomes any initial considerations by Tribal leaders as the Agency develops a review process.

Commission Publishes First-Ever Bulletin on Human Trafficking and Highlights Resources

During the month of February 2021 the NIGC will publish the first-ever agency bulletin on the topic of Human Trafficking. In addition, a dedicated portion of the NIGC website will feature and highlight resources to assist gaming operations and regulatory bodies' efforts to combat human trafficking. In a recent statement on the topic of human trafficking, the Commission noted the important role operations and regulatory bodies can and have played to combat the human cost from human trafficking that impacts tribal communities and neighboring jurisdictions. These efforts are in addition to the Commission's work over the last several years to bring awareness and education to issues surrounding Human Trafficking. Some of the NIGC's initiatives include partnering with the FBI and BIA to present Human Tracking awareness training at our Regional Training Conferences and hosting events with other organizations such as the National Center for Missing & Exploited Children and Truckers Against Trafficking. The Commission looks forward to continuing to highlight the Indian gaming industry's unique and important contributions in this area.

Commission Publishes Bulletin Underscoring the Independence of Tribal Gaming Regulatory Bodies and Their Functions.

During the month of February 2021, the NIGC will publish a bulletin on the topic of Tribal gaming regulatory authorities roles and independence. Tribal regulatory bodies are an important part of the NIGC's government-to-government relationship and essential for a comprehensive regulatory framework to protect both the integrity of gaming and the interests of a tribal government. The Indian Gaming Regulatory Act outlines the specific governmental regulatory responsibilities necessary to game under the law. Very often, Tribal gaming commissions are an appropriate type of governmental agency to implement these regulatory responsibilities. While each tribe's approach to satisfying these requirements will be specific to each tribal government,

specific measures to ensure independence have been an important consideration for a healthy regulatory framework. During the COVID pandemic the commitment by tribal governments' decision makers has underscored the value and unique role of a healthy tribal regulatory framework.
